1. Call to Order

President Kwon called the meeting to order at 1:31 PM.

2. Roll Call

Present: Kwon, Courtney, Vietor, and Moran

Excused: Caen

3. Approval of the Minutes of May 22, 2018

On Motion to approve the Minutes of May 22, 2018:

Ayes: Kwon, Courtney, Vietor, and Moran

No public comment.

President Kwon announced that item 12 was pulled from the calendar and will be rescheduled.

4. General Public Comment

 Francisco DaCosta discussed investigations he is undertaking regarding community benefits. He indicated Commissioners did not attend task force meetings. He stated grants need to be monitored to see who is getting funds and how much.

Vice President (VP) Courtney replied to Mr. DaCosta's statement that the Commission did not attending task force meetings. He indicated he was unaware of those meetings and asked that staff notify the Commission of such meetings.

 Nicole Sandkulla, BAWSCA, commented on the WSIP changes and noted BAWSCA's previous request for an accounting of actual financing costs prior to any budget adjustments. She addressed the WSIP budget adjustment adopted in April and stated that the SFPUC requested an extension to June 1st to provide the accounting report to BASWCA, and that they have not yet received the report.

Commissioner Vietor asked that the report be presented to the Commission when finalized. General Manager (GM) Kelly noted the reason for delay. In response to a question as to when the report will be ready, Eric Sandler, Assistant General Manager (AGM), Business Services, stated the it will be ready within the next couple of months.

6. Other Commission Business None.

7. Report of the General Manager

a) CleanPowerSF Update

Barbara Hale, AGM Power, provided a CPSF update: (1) <u>Enrollment</u>: Serving 81,000 accounts; 3.2% opt-out rate; 4.2% SuperGreen upgrade rate; July 1st auto enrollment underway which will increase the customer count to approximately 105,000, with the addition of mostly commercial accounts; (2) <u>Regulatory</u>: PCIA hearings concluded with briefs filed and proposed decision expected in summer. AGM Hale discussed and expressed concern with the recently published California PUC Customer Choice report. She stated June 11th is the deadline for comments and that a legislative-style hearing is scheduled for June 22nd.

No public comment.

b) <u>Sewer System Improvement Program (SSIP) Quarterly Update</u>
Karen Kubick, Wastewater Enterprise Capitol Program Director, presented
the SSIP Quarterly Report and Triple Bottom Line Update: (1) <u>Program</u>
<u>Status</u> (Phase I 22.6% complete); (2) <u>Biosolids Digester Facilities Project</u>
<u>Timeline</u>; (3) <u>Southeast Plant Headworks Facilities Project Timeline</u>; (4) <u>SSIP</u>
<u>Phase 1 jobs report</u> (32% actual SSIP local hire percentage achieved); and
(5) Stakeholder outreach.

Director Kubick continued with a presentation of the SFPUC's Triple Bottom Line: (1) Evaluating alternatives; decision-making support; and project selection transparency/reporting facilitation; (2) What went into making TBL (assessment model); (3) TBL Indicators (social, environmental and financial); (4) TBL Output (TBL bottom-line analysis); (5) How has TBL model been utilized on the SSIP (Holloway Green Street alternatives and TBL results, New Headworks Facility alternatives, TBL results, and rendering); (2) New Headworks Facility (alternatives and results and rendering); (6) TBL Analysis (Phase 1 Projects); (4) How to access SFPUC's TBL executive summary; and (5) Next steps.

Director Kubick responded to a request from Commissioner Moran for clarification as to what "including TBL into communications materials" means. Brief discussion ensued.

Director Kubick responded to Commissioner Moran's question as to the existence of a complete summary of decisions on the SSIP and noted the need for documentation.

Commissioner Vietor asked that the TBL information be distilled into something more understandable and be communicated on the web to inform the public of projects and their values.

GM Kelly noted the TBL is part of the project evaluation process and he wants to make it part of project delivery and a project tool. He stated reports can be pulled, if requested.

Commissioner Vietor questioned how to monetize, value, and quantify additional non-financial benefits of the TBL. GM Kelly noted that care must be taken when placing a value and noted there are software programs that can assist in those efforts, which are being evaluated.

President Kwon thanked Ms. Kubick on great work.

Public Comment

- Francisco DaCosta stated it needs to be kept simple. He discussed the 2002 bond measure which addressed the SSIP and WSIP. He stated the community has been let down and that there has been no mention of health and community benefit or quality of life issues.
- c) <u>Wastewater Capital Improvement Program Quarterly Report</u> *Karen Kubick stated there has been no deviation from the baseline.*

She informed the Commission she is retiring and it was her last presentation before the Commission. She stated it has been a pleasure to see the project's progress and to work with the SFPUC staff and the Commission.

GM Kelly thanked Ms. Kubick for her work and reviewed his history of work with Karen.

Public Comment

- Francisco DaCosta thanked Karen for embracing the Bayview Community.
 He discussed her important role with the SSIP and her efforts to
 accommodate constituents to the best of her ability. He thanked her on
 behalf of the community.
- d) Report on Recent San Francisco Public Utilities Commission Activities, Events and Announcements

GM Kelly stated that Proposition A passed with approximately 80% of the vote.

No public comment.

8. Recognition of Tracy Yamaguchi upon her retirement after 27 years of distinguished service to the SFPUC

GM Kelly introduced Tracy Yamaguchi and summarized her career, which includes positions in the Controller's office, San Francisco Airport, and 27 years with the SFPUC. He thanked her for her work and congratulated her on her retirement.

Ms. Yamaguchi thanked GM Kelly and the Commission for the recognition. The Commission presented Ms. Yamaguchi with a retirement certificate.

No public comment.

9. <u>Green Infrastructure (GI) Early Implementation Projects (EIP): Monitoring and Lessons Learned</u>

Brian Henderson introduced Polly Perkins, Utility Planning Division, who presented on the following: (1) <u>EIP monitoring locations and strategies</u>; (2) <u>Why monitor GI</u> (evaluate performance and build knowledge); (3) <u>Cesar Chavez Green Street</u> (annual performance and Level-of-Service (LOS) performance).

Ms. Perkins responded to a question from Commissioner Moran as to how the percentage of reduction measure is determined.

(4) <u>Oak and Fell Green Street</u> (estimated and actual volume reduction, and annual peak flow reduction); (5) <u>Sunset Model Block Monitoring Results</u> (estimated and actual volume reduction, and annual peak flow reduction).

Ms. Perkins responded to a question from Commissioner Vietor as to whether there is measurement of flow that doesn't enter the system, and about the runoff reduction (predicted vs. monitored).

(5) <u>Sunset Model Block Monitoring Results</u> (estimated and actual volume reduction, and annual peak flow reduction); (6) <u>Upcoming EIP monitoring</u>; and (7) <u>Preliminary EIP Monitoring Conclusions</u>.

Commissioner Vietor thanked Ms. Perkins for her presentation.

Sarah Bloom, Utility Planning Division, reported on the top EIP lessons learned: (1) <u>Establish cost-effective metrics for GI projects</u>; (2) <u>Identify site constraints early in the site selection process</u>; (3) <u>Use a programmatic approach to encourage others to implement green infrastructure</u>; (4) <u>Implement capital projects on large parcels by leveraging key city partners</u>; and (5) <u>Develop standard GI project delivery process for efficient implementation</u>.

Sara Minick, Utility Planning Division Manager, responded to a question from VP Courtney Vince as to how many projects are in-works, and how the current projects are maintained (Job Order Contract and labor model). GM Kelly provided additional response.

VP Courtney stated he would like to see more thought given to career pathway opportunities for under-represented and under-served communities.

GM Kelly noted that as part of the grant process criteria could include that community members be hired.

Commissioner Vietor stated the workforce component is key as the projects move from a minor to a major scale. Brief discussion ensued.

Ms. Minick provided clarification to the presentation regarding percentages in reduction.

President Kwon thanked Commissioner Vietor for her leadership around GI.

Public Comment

- Francisco DaCosta stated he attended the first GI workshop and there were no community members in attendance, and the workshop were given by consultants. He stated there was no follow-up or certificate provided. He noted concerns from contractors of materials production in China.
- 10. Update on federal legislation and appropriations relevant to SFPUC operations including the Water Infrastructure Finance and Innovation Act program, State Revolving Funds, Ocean Beach Replenishment, Workforce Development, and Federal Energy Regulatory Commission Proceedings

 Emily Lam, Director Policy and Government Affairs, provided an update on federal legislation and appropriations relevant to SFPUC operations. She discussed the Water Resources Development Act, which is before Congress, highlighting the finance and workforce development sections of the Act. She provided a status update to several appropriations bills of interest to the SFPUC.

Michael Carlin, Deputy GM, responded to a question from Commissioner Vietor regarding the status of the National Marine Fisheries Service (NMFS) Appropriations Bill Rider and the likelihood of passage.

GM Kelly stated that the SFPUC will take a position through the Mayor's Office and will work through that process.

GM Kelly responded to a follow-up question from Commissioner Vietor regarding the SFPUC's position, indicating he is also waiting to hear the positions of Senators Feinstein and Harris.

Commissioner Vietor requested that an update on the proceedings with the State Water Board be provided.

Public Comment

- Peter Mangarella, Trout Unlimited, discussed the Alameda Creek Watershed and the New Don Pedro Dam. He asked that the SFPUC oppose the Rider.
- John McManus, President, Golden State Salmon Association, urged opposition to the Rider and expressed concern with precedents.
- Noah Oppenheim, Executive Director, Pacific Commercial Fishermans' Association, expressed opposition to the Rider and any policy that would prevent NMFS from implementing authority under the Federal Power Act.
- Peter Drekmeier, Tuolumne River Trust, asked where the SFPUC stands with regards to attacks on the environment. He discusses Senator

- Feinstein's position and communications with the SFPUC. He requested the Commission oppose the Rider.
- Barry Nelson, Golden Gate Salmon Association, discussed the multiple riders the salmon industry is fighting. He asked that the Commission oppose the Rider as soon as possible.
- Francisco DaCosta, commented on the previous speaker's words and stated the Commission needs to pay attention. He discussed Raker Act requirements.
