Topics of Discussion:

- The committee expressed concern about water disinfection byproducts since there have been high levels of organic compounds. Steve noted that the enterprise will have to wait to see if this is a trend or an abnormal occurrence.
- The committee discussed the range of Hetch Hetchy water and power sources. Steve clarified that it expands past the city limit to the Alameda East Portal.
- The committee showed concern about the Oroville Dam crisis and asked if there would be retrofitting or increased infrastructure.
- The committee asked why the enterprise is implementing powdered activated carbon treatment at the Sunol Valley Water Treatment Plant. Steve explained for quality control; improve taste and odor
- The committee asked how much workload will be needed to remove the decaying trees in the Bioregional Habitat Restoration Program. Steve noted that the task is by contract and will cost \$1.5-2M.
- The committee discussed the 4 year rate package and 2 year budget then asked what the water enterprise's low priorities are: Alameda Water Creek Center, Millbrae lab and facilities, Moccasin power house.
- The committee discussed maintenance and how it is integrated in the budget cycle because there are some pieces of the Water System Improvement Program (WSIP) that does not fix or maintain all pipes.
 - Member Clary informed that the committee wrote a resolution in the past regarding maintenance then suggested resurrecting it.
- The committee referred to the General Manager's address and issues regarding the government hiring process and how that creates gaps in employment exacerbating workforce succession.
