- *Member Nagengast* asked where does the Hetch Hetchy water stop on the operational systems map.
  - AGM Ritchie responded that the water stops at the Alameda East Portal.
- Member Nagengast asked why Hetch Hetchy Water and the Water Enterprise separate.
  - *AGM Ritchie* responded that the SFPUC restructured its organization in the early 2000s into enterprises, which is the main reason they are separate.
- Member Clary asked for the status of the asset management plan.
  AGM Ritchie responded that the status is different in various parts of the plan, however, they do plan to release a status report this year.
- Member Clary wanted to clarify that there has been an ask to increase the operating budget.
  - AGM Ritchie responded, yes.
- Member Nagengast asked if there is a position in the operating budget that will further the SFPUC educational goals.
  - AGM Ritchie responded that they currently do not.
- Member Kott asked about the budget percentage increase.
  AGM Ritchie responded that he is currently unable to share that information
- Member Clary asked if they are looking at Prop1 as an example to fund their damns.
  - AGM Ritchie responded, yes.

# **Presentation Discussion:**

- *Member Clary* asked if the EFWS map analysis considered earthquakes. *Staff Scarpulla* responded that they are considering various situations and elements when developing the map analysis.
- Member Clary asked if the EFWS system is compartmentalized.
  Staff Scarpulla responded that it is compartmentalized to be able to fight fires in different neighborhoods.

- Member Perszky asked if there has been public engagement on the EFWS project.
- Staff Scarpulla responded, yes that there have been several public and community presentations to inform the public on the EFWS system.
- Member Clary stated that inner neighborhoods are disproportionately being served at the expense of outer neighborhoods.
- Clary then asked if there are projects in the outer neighborhoods that provide them short term security.
   Staff Scarpulla responded that several small projects in outer neighborhoods are currently in development.
- Member Nagengast suggested that there should be a timeline to help provide clarity of the EFWS goals.
