

7 DAY CONSTRUCTION NOTICE

WATER SYSTEM IMPROVEMENT PROJECT Sutro Reservoir Drainage Channel

When: Construction is anticipated to begin February 19, 2024 with completion anticipated by April 1, 2024. Weather and construction issues could impact the schedule. General workdays and hours (weather permitting) are Monday – Friday, 8:00 a.m. to 5:00 p.m. Some weekend work may be required.

Where: Work is planned to occur within the asphalt perimeter of the Sutro Reservoir.

Why: To ensure safety for the public (i.e., walkers, runners, dog walkers and bench sitters) and staff, SFPUC plans to install a concrete curb surrounding the drainage channel.

What to expect during construction: Work is done in phases, so work will not be happening on the entire circumference at once. There may also be periods of inactivity during the work dates. The entry gates will be locked and the entire area will be closed to the public for the duration of the construction project.



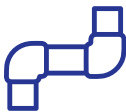
Contractor will place “Closed to the Public” signs on the entrances to the reservoir.



Contractor will power wash the existing concrete curb to provide a level area free of dust, moss and other debris. There will be noise, vibration, dust, parking and traffic impacts in/near the work zone and some disruption to normal neighborhood activity.



Section by section, the Contractor will install rebar, prepare and build wooden forms for extending the height of the concrete curb surrounding the drainage channel. Concrete will be pumped into the forms which will be removed once the concrete has cured to the correct strength. The Contractor will move on to the next section. All work will be performed in the reservoir area.



There will be no interruption or change to your water or sewer service.



Once the entire project has been completed, all equipment and materials will be removed. Public access to Sutro Reservoir will be restored.
