- Member Steen asked what PUC's expectations are to renew the tariff.
 Barbara informed that the decision was prolonged due to Federal
 Energy Regulatory Commissioners transitioning and not maintaining a quorum to vote.
- Member Kott asked the status of the John F. Kennedy senior housing towers remodel and who is the electricity provider (PUC or PG&E). Kott further asked for clarification on CleanPowerSF's "competing objectives." SFPUC provides power to the JFK towers. Staff Hale informed that residents are relocated during the remodel. Staff Hale clarified that the competing objectives are affordability, clean energy and local jobs; the goal is to have a balance between the three (e.g. finding a balance between having the cleanest energy that is also affordable.)
- Member Ekanem asked
 - 1. How the conflict between competing energy providers (PUC and PG&E) affects rates especially for low income families?
 - 2. Will the competition mentioned above delay the construction projects in District 10?
 - 3. How does the PUC enterprise taking air quality into consideration?

Staff Hale informed that the conflict is not affecting rates but it is increasing the costs of the remodeling rather than the cost of service to provide electricity. Then stated that not all the construction projects in District 10 are PUC projects but the enterprise is looking to expand the campus power distribution to get ahead of the conflict. Lastly stated, CleanPowerSF is combating poor air quality by providing GHG free power.

 Member Loewenberg asked if CleanPowerSF rates will remain stable during the conflict. Staff Hale informed that they were able to keep rates competitive and will aim to stay below the rates of other power providers. Member McHugh asked if the SFPUC has any updates to report on regarding the PCIA exit fee that CPUC has recently reformed.

- Member Loewenberg asked if landlords can pass the increasing rates to their tenants. Staff Prada informed that landlords can pass the rates to tenants but they have to go through a separate rent board control process.
- Member McKinney asked
 - 1. How does the PUC get information out to renters who do not manage their water and sewer bill?
 - 2. Is the PUC is working with large property owners to disseminate information to their tenants about the rate increase?
 - 3. The water/sewer bill calculator be on the SFPUC main website landing page.

Staff Prada mentioned that outreach through social media outlets have been helpful to engage with tenants who don't see their bill but ultimately it's up to landlords to inform their tenants.

- Member Loewenberg asked how much money is being spent to run the rebate programs. Staff did not know the answer and would have to get back to the CAC with that information.
- Member McKinney asked if there will be a comment period during the Prop 218 Notice. Staff Prada informed that you can write a letter, submit a comment to ratesinfo@sfwater.org or attend the Rate Fairness Board meeting on March 2 and the Commission meeting on April 10.
